## Where We Are: Housing Crisis!

- Over 180K homeless
- Over 80% of low-income households are "rent burdened"
- Home prices ~\$800K (affordable to top 18%)
- Existing deficit: 1.5M 3.5M


## How We Got Here: Demand > Supply

Demand is high

- Supply is constrained:
  - Hard to Build "Out"
  - Hard to Build "In"
  - So Many Ways to Get to "No"
  - Not enough/inconsistent \$\$\$
  - Not enough workers

## How We Got Here: Demand is High

- Weather
- Natural Amenities
- Culture
- Jobs!
  - 8 million in the past 40 years
  - 3 million in from 2010-2020

Cities control zoning

- Cities limit land zoned for housing:
  - Fiscal policy
  - Local politics

#### So Many Ways to Get to "No"

- Entitlement Process
  - Typically: many decision makers, lack of clarity, expensive process
  - Each city: unique policies, process, players

- Environmental Regulation (CEQA)
  - Presumes no development is good
  - Empowers everybody to delay projects


#### **Not Enough \$\$\$**

#### What We've Done: Increased How Much Can Built

#### RHNA and Local Zoning:

- Planning for 2.5M units (6<sup>th</sup> cycle)
- Up from 1.1M units (5<sup>th</sup> cycle)
- Require housing in high-opportunity areas

#### State Override of Local Zoning:

- ADUs
- SB 9
- AB 2011/SB 6

- Housing Element

- Enforcement

#### State-mandated by right approval:

## What We've Done: Increased \$ for Affordable Housing

- SB 2 permanent source/ SB 3 Housing Bond
- Local funding efforts (bonds, taxes)
- State GF
- \$500 Million for LIHTC
- Over \$11 B in GF (2021-22)

#### What We've Done: Better Approaches to Homelessness

- Implement best practices (housing first)
- Increase state coordination (HDIS, Cal ICH)
- Increase local coordination (HHAP)
- Increase funding
- Increase focus on prevention (ERAP)
- Increase oversight

# What We've Done: Better Working Conditions for Construction Workers

Use the carrot approach by giving multi-family housing developers special benefits if they use "high road" labor standards (SB 35, AB 2011, SB 6, SB 423)

#### What We've Done: Protect Tenants

- Establish rent caps and just cause eviction protections (AB 1482)
- Provided \$B in emergency rental relief

#### What's Next: Production

- Enforce! (local rezoning, HE programs, HAA)
- Perfect (AB 2011)
- Affordable housing: fund affordable housing build counter-cyclically
- Market-rate: wait for market conditions to re-align

- AB 3160 (Gabriel) Makes \$500 million of Low Income Housing Tax Credits Permanent
